



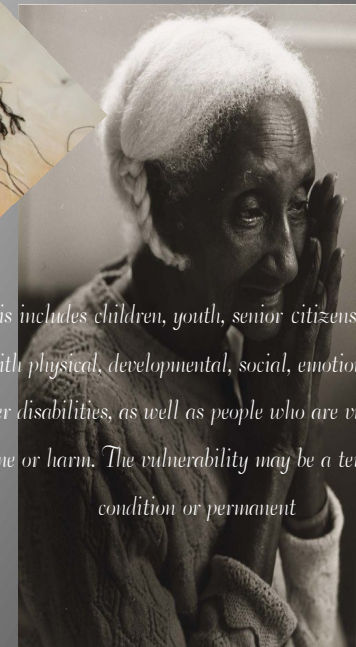

are defined in the *Criminal Records Act* as persons who, because of age, disability, or other circumstances, whether temporary or permanent are:

- * In a position of dependence on others or
- * Are otherwise at a greater risk than the general population of being harmed by a person in a position of authority or trust relative to them.



This includes children, youth, senior citizens, people with physical, developmental, social, emotional, or other disabilities, as well as people who are victims of crime or harm. The vulnerability may be a temporary condition or permanent

Mike's original training was as a pastoral /addictions counsellor/ parish priest in the Anglican Church. For over 10 years he served in a number of remote communities in North Ontario and Quebec, including his home reserve north of Thunder Bay. Since 1992 he has worked in several mental health and addictions agencies as a front line therapist and supervisor. He has clinical supervisor status with the Canadian Addiction Counsellor's Certification Foundation, and is a registered social worker with the OCSWSSW. Mike has been involved in the Toronto Centre for Psychodrama and Sociometry since 1993 and graduated as a TEP (Trainer, Educator and Practitioner) in 2012. He has conducted workshops and trainings on such varied issues as: male and female sexual abuse, the Enneagram in Action (a model for personal and spiritual growth), Verbal Self Defense, Working with Stereotypes, and the Medicine Wheel of Core Emotions, a model for healing from trauma. He was also part of the Fireweed project which developed a treatment model for recovery from sexual abuse.

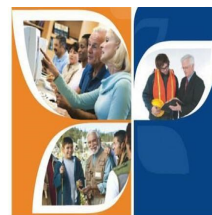

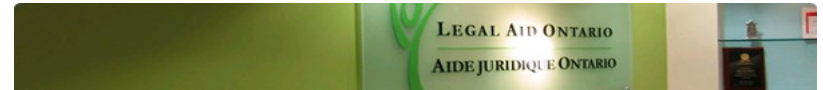

Professor Solomon, LL.B. 1970, Osgoode Hall Law School, LL.M. 1972, Yale Law School is currently on the Faculty of Law at the University of Western Ontario and is the National Director of Legal Policy for Mothers Against Drunk Driving (MADD) Canada. In 2013, he was appointed to the rank of Distinguished University Professor. He has been involved in research and teaching on health care, civil liability and criminal law for over 40 years. He has served as a consultant to Health and Welfare Canada, the Law Reform Commission of Canada, the Canadian Centre on Substance Abuse, and the Commonwealth of Australia Health Department. Professor Solomon has travelled throughout Canada and Australia presenting legal programs in his fields of expertise. One of his major areas of recent concern has been the increasingly challenging legal environment facing social workers, health practitioners and youth workers. He has advised numerous health, care and counselling agencies. He has written extensively on these issues, and is the lead author of *A Legal Guide for Social Workers*, 2nd ed., published by the Ontario Association for Social Workers. He has also served as a consultant to law firms working in the health, care and counselling fields.
